The group has fully drawn senior debt facilities of \$61.564 million at the end of the quarter. Approximate half of this total senior debt is subject to an agreed amortisation schedule over the coming 3 years, with the remainder repaid in full at facility maturity in 3 years. The Company pays a commercial interest rate on these facilities.

A further \$15 million loan has been provided by the purchaser of the purchased debt ledger assets which were sold as part of the refinancing transaction announced in December 2020. The loan is repayable no earlier than October 2021 and is subject to a commercial interest rate.
